SAFETY START PROGRAM



A FREE two-day 14 hour course in emergency first aid with Level A CPR and occupational health and safety is being offered to New Brunswickers aged 15 to 29 to decrease the number of injuries sustained by young people in the workplace. **However, any Off-Reserve Aboriginal person in NB who is a current NBAPC-ASETS program client* (regardless of age) is able to take this program free of charge.** Simply contact the number below to arrange a training date and location and then call our department to notify us you will be attending.

Upon completion of the course, you will receive a Health and Safety Passport which you can add to your resume of skills. The Province of New Brunswick will give hiring preference to those who complete the **Safety Start Program**.

I would like the assistance of all community members to provide pictures/images of any or all harvesting activities, also I would love to receive drawings, sketches that you or your children would like to create that reflects any harvesting activities. Any or all creations will be utilized in the calendar. I am also looking for Recipes that I can utilize in the calendar for example a recipe that may use striped bass, trout, mussels, or clams whatever seafood that is part of our community harvest (what species that are part of our licences. The deadline for submission is September 30, 2013.

The Striped Bass fishery is open from May 8, 2013 to September 30, 2013, NBAPC has an allocation of 1000 Striped bass in combined total, and there are no size requirement and no daily limits. The Striped bass licence has been mailed to all members that are currently harvesting under the AFS, if you have not received your licence please contact Nathalie Wysote to make an appointment to receive your licence.

- Members who are currently harvesting Striped Bass in the Chaleur Fishery area, Miramichi Fishery area, and Southeast Fishery area as part of the licencing requirements you must submit harvesting reports on a weekly bases. Members can submit their reports by phone, email, or fax contact information is below.
- Chaleur Fishery Area: means all lakes, rivers, and streams draining into the bay of Chaleur seaward of the J.C. Van Horne Bridge at Campbellton and all waters draining into the Gulf of St. Lawrence north of Tabusintac Bay.
- Miramichi Fishery Area: means all lakes, rivers, and streams draining into Tabusintac Bay and all waters draining Miramichi Bay north of Point Escuminac.



- Southeast Fishery Area: means all lakes, rivers and streams draining into the Gulf of St. Lawrence and Northumberland Strait south of Point Escuminac to the New Brunswick/Nova Scotia border.
- Reminder to all members who are participating in the Aboriginal Fisheries Strategy Arrangement (AFS) 2013-14, all harvesters must send or call in your bi-weekly reports. This is an important tool that is used in reporting and also in negotiations with Department of Fisheries and Oceans Canada (DFO). 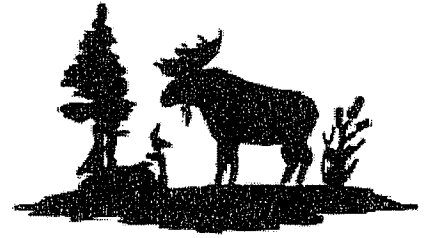

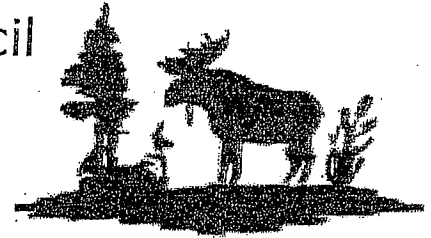

Hello everyone,

I have received some Kidsport applications in over the last week. I will be taking them in next week after the Summer Games but I do have some issues about a few of them. When they are being filled out please have a look at them before sending them, I also need you to look over the Adult Endorser portion of it. Here are a few things that I have noticed.

1. The adult endorser must be signed by a member of the police, nurse, health official, clergy. It can not to be filled out by a sport director or rec director.
2. The Kidsport program is for grassroots athletes, we will only be looking at first time youth in a sport then we go onto the next 3. To be eligible for funding the sport you are going to be playing in must be part of a Provincial Sport Organization (PSO) Dance does not have a PSO 4. We can not put through the child of someone that is part of Chief and Council. They do make a good amount of money to afford it.
5. We can not put through someone that is playing high school sports or competitive sports. If a child can play at that level they must have had some help to get them there.
6. The kidsport is for team sports such as hockey, ball etc. It is not for summer hockey school or events that you have to leave the Province for.
7. We are only able to pay 300 towards the registration as we are limited on what we have for money. Travel, equipment can not be paid.
8. Anyone applying must fill the whole application out, if the child is selected to get funding the money will go directly to the sport organization itself. NO MONIES WILL BE GIVEN TO A PARENT. It has happened in the past that the parent received it and then the child dropped out of the sport.
